

## **TERMS AND CONDITIONS FOR “The Loxford Launch” PROMOTION**

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this “**The Loxford Launch**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in New South Wales local time.

### **ELIGIBILITY**
